The organizers of Copenhagen Historic Grand Prix are committed to the protection of the environment and to do our part in decreasing our carbon footprint within motorsports and events. In collaboration with Danish Automobile Sports Union (DASU) and with the support of our stakeholders we are able to introduce realistic green initiatives to become a greener event and hopefully, achieve our future goal of receiving our 1<sup>st</sup> star within the FIA Environmental Certification Framework.

Though we are moving forward to be a greener motorsport event, it is not to say we haven't already started. Last year, in 2021, we introduced Green City, an area that is specifically set up for exhibitors and companies to showcase their green initiatives and the future of sustainability.

To ensure that we continue on our green path and ensure we track our progress, we have created the following green and sustainable objectives and goals. These are as follows:

- Continue to work with and follow the regulations of Copenhagen Municipality and the Copenhagen Police department to ensure that we continue to follow all laws and regulations
- Continually create, measure, and revise our green initiatives
- Increase the use of sustainable materials in regards to our merchandise and building materials
- Increase our presence and do our part in local communities
- Ensure that all participants, suppliers, volunteers, and exhibitors follow new regulations
- Only utilize electric vehicles or bicycles within the exhibition grounds
- Introduce bus shuttles in Jutland and Funen to transport spectators to our event, to decrease car transport
- Find and introduce energy-efficient and sustainable solutions
- Reduce food and material waste or ensure they are recycled in the most eco-friendly manner
- Implement a 100% bio-fuel initiative for all participating drivers
- Educate younger generations on the future of green energy and motorsports
- Use our social media platforms to inform and spread knowledge about eco-friendly initiatives and information

Through the implementation of these initiatives and objectives, Copenhagen Historic Grand Prix, most importantly, hopes to decrease our environmental impact and carbon footprint. We hope that this will therefore lead Copenhagen Historic Grand Prix to become the first CO2-neutral race event in Denmark and become a market leader in green events.
