Terms and conditions of purchase of entrant registration for CHGP

Conditions:

Garages/tents in Paddock may only be used for racing cars, tools and pit crew.

Merchandise, water, food and beverages may NOT be sold from the paddock.

Garages/tents in Paddock may not be used as a lounge, i.e. for entertainment, dining etc.

Garages/tents in Paddock may not be used by, or resold to, another party.

Social interaction between drivers is referred to the classes' allocated tents.

If an area for entertainment, catering for staff and/or customers is desired, a lounge must be purchased.

Prices:

All prices are current prices applicable only to the day of purchase and are thus subject to change. All prices include V.A.T. The price of the entry fee includes an administrations fee of DKK 625 if registered after March 31st 2024. On "Early Bird" registrations before March 31st 2024, the administration fee has been removed.

Sale and delivery:

The registration is only valid when payment has been received. After paying you will receive a receipt which must be presented upon request at your arrival to the event.

Payment:

We accept Visa or MasterCard. Payment will be drawn when your request to enter the race has been received and registered.

Right of revocation:

- a) Should you cancel your registration within the registration deadline of June 30th 2024, we will refund 90% of the registration fee and of any additional purchases. The administrations fee of DKK 625 will not be refunded.
- b) Should you cancel your registration between June 30th and July 15th 2024, we will refund 50% of the registrations fee and 0% of any additional purchases. The administrations fee of DKK 625 will not be refunded
- c) Should you cancel your registration after July 15th 2024, no fees will be refunded.

Claims:

Should you wish to report any flaws or deficiencies detected, you must immediately and without hesitation inform Copenhagen Historic Grand Prix hereof in writing. Failure to do so may result in loss of right to validate the flaw or deficiency at a later date.

Data protection:

Your personal data will be stored in our customer register.

Copenhagen Historic Grand Prix is responsible for this and will use it to send you information.

You are always entitled to know what information we have registered on you and, according to the Danish Data Protection Act, you can take exception to any registration. When enrolling, you confirm, that you have read the "Information concerning processing of personal data".

Information about the event

When registering as driver, you accept that CHGP sends you emails containing important information before the event. You also accept that CHGP sends you emails concerning drivers' registration the subsequent year. You are always entitled to unsubscribe this.

Disputes:
